- Each vendor must display a sign identifying the name of the vendor/business.
- Vendors are required to know and have appropriate labeling on their products.
- Kid Market products/services/businesses must be primarily provided/run by the child participating with minimal help from the parent or guardian.
- There is no cost for Kids' Day Market Vendors, but no call/no shows will not be considered for future markets.
- Vendor participation is subject to approval and is not guaranteed. You will be notified. Space availability is on a first come basis, and NO DROP INS, you must pre-register.
- Applications must be returned by Sunday, July 26, 2026.
